
ePlan Protocol

Version 2 of the ICSM ePlan Protocol set of documents was finalised and ratified by the ICSM at its Perth meeting in November 2010. The ICSM ePlan Protocol consists of a suite of documents and XML schema files. These include:

- The Logical Model that maps survey plans into a logical data structure
- The LandXML Mapping that maps the logical model to the physical file format (LandXML)
- The Structural Requirements that defines complex representations of data in LandXML
- The Schema Architecture that defines the relationships between the XML files that comprise the Protocol
 The LandXML Schema
- > The suite of ePlan XML Schema files; a subset of the LandXML Schema specifically for ePlan

LiDAR Acquisition Specifications and Tender Template

In recent years dramatic developments in airborne LiDAR technology and industry capabilities have revolutionised our ability to capture terrain information to address issues such as flooding, sea level rise and water management. However, inconsistent and diverse product specifications, and variable data quality are often making it difficult to integrate datasets to address regional, state and national issues.

ICSM has released new national LiDAR specifications to assist both purchasers and providers of high resolution elevation data. The intent is to further improve on the quality, consistency, utility and compatibility of data being captured

by government and the private sector. Moreover, the specifications and tender template provide opportunities for greater collaborative investment across all levels of government, and capacity to reduce tender and compliance costs for investors and providers

New Working Groups

At the November 2010 meeting ICSM created two new working groups:

Points of Interest (POIWG)

This group will review issues and activities associated with points of interest information and develop a strategy for progressing the national capture of points of interest data.

Bathymetry (BWG)

This group will review issues associated with seamlessly capturing and managing land and marine data. Issues that will be considered include:

- recent rapid expansions in technology which are capable of capturing depth information (such as LiDAR)
- urgencies associated with environmental issues (such as tsunami warning and climate change)
- the emergence of web based packages such as the National Elevation Data Framework (NEDF) portal



ICSM Executive Officer Retires

In closing this report ICSM members would like to thank Susie Salisbury for all her efforts over the last seven years as ICSM Executive Officer and wish her a long and happy retirement.

Protection of National Survey Marks

ICSM has held a series of discussions with the National Broadband Network Company (NBN Co). As a result NBN Co has placed a requirement on contractors to preserve survey infrastructure and comply with legislation related to survey mark preservation. These requirements would then be included in their construction plans so that permanent survey marks are not damaged.



Also, in conjunction with this, ICSM has engaged with Standards Australia in preliminary discussions regarding the development of a national standard for the location and recording of underground services – such as telecommunication cables.

ICSM and Creative Commons

Creative Commons Attribution (CC BY) licensing has now been adopted to manage copyright for ICSM standards, guidelines, policies, protocols and documents. See the Creative Commons website for more information about Creative Commons licences: http://creativecommons.org.au/learn-more/licences.
